4210 - Instructional Media

Instructional Material Washington County School District - Adopted 8-79; Revised 5-9-06

1. Purpose:

The mission of Instructional Media is to ensure that all students proficiently use information in various formats, provide a wide range of learning resources at varying levels of difficulty, utilize diversity of appeal and points of view to meet the needs of students and teachers.and **Te-**support the educational mission of the School District by providing personnel, facilities, equipment and materials for the use of students and teachers in the teaching-learning process.

2. Policy:

2.1. Public organizations shall be permitted to use audio-visual aids equipment provided a competent member of the school staff accompanies the machine for the purpose of operating the equipment.

2.2. All instructional material shall be age appropriate for each individual student who has access.

2.3. Washington County School District employees are responsible to ensure that school media centers and libraries contain material of diverse origin, background, and views but is not obviously offensive to prevailing standards in the school's parent community as a whole with respect to what is suitable material for minors of the school's age group.

2.4. Washington County School District supports the freedom of inquiry, including: intellectual and academic freedom in that every student and teacher is able to both seek and receive information from all points of view; this provides for free access to all expression of ideas through which any and all sides of a question, cause or movement may be explored.

2.5. Willful or reckless disregard of this Policy may result in disciplinary action pursuant to District Policy 1450.

3. Procedure:

3.1. Definitions

3.1.1 "Material" has substantially the same meaning as defined in UCA 76-10-1201, to include any Any physical or digital form of material including anything printed or written or any picture, drawing, photograph, motion picture, or pictorial representation, or any statue or other figure, or any recording or transcription, or any mechanical, chemical, or electrical reproduction, or anything which is or may be used as a means of communication. Material includes undeveloped photographs, molds, printing plates, and other latent representational objects.

3.1.2. "Harmful to minors" incorporates the meaning given in UCA 76-10-1201, to include, the material content of any description or representation, in whatsoever form, of nudity, sexual conduct, sexual excitement, sadomasochistic abuse, suicidal ideation, parasuicide, self harm, etc. when it:

- Is obviously offensive to prevailing standards in the adult community as a whole with respect to what is suitable material for minors; and
- taken as a whole, does not have serious value for minors.
- Serious value includes only serious literary, artistic, political or scientific value for minors.
- 3.1.3. "Standards for material selection"

Material shall be selected using the following criteria:

- The material has identifiable literary value.
- The material has positive social and moral value.
- The material will help students develop a better understanding of themselves and others.
- The material has identifiable aesthetic value.
- The material is appropriate for the purpose for which it is to be taught/used.
- The subject matter, reading level, and the maturity level of the material is appropriate for the student using the material.

Material shall not be selected that contains:

- Material deemed "Harmful to minors" as defined in U.C.A. §76-10-1201.
- Content inappropriate for the school's age group due to profanity.
- Content inappropriate for the school's age group due to violence.
- Content promoting or idolizing suicide.

3.2. District Media Production Center

3.2.1 The hours of operation for the District Media Center are normally 8:00 A.M. to 4:30 P.M. daily. Any variations, along with the regular schedule are posted on the District web site at least one week in advance. This schedule is, also, posted on the District Media Center door. The District is a member of the UIMC, to which it pays an annual fee assessed by the State Office of Education and which is calculated from LEA enrollmentenrolment. The UIMC is the primary supplier of audio/visual media materials for classroom use within the District. This membership allows an LEA's designated person to participate as a voting member of the consortium, as well as the opportunity to become an elected officer. The voting member represents the LEA's best interests in the previewing, content, and Statewide purchase of audio/visual media materials through the consortium. Negotiations by the consortium include pricing, copyright agreements, duplication privileges, broadcast rights, and retention options.

The materials obtained are then owned by the LEA and are exclusively for classroom use. Upon the termination of any teacher or aide in the possession of LEA obtained audio/visualmedia materials, said materials will remain in the possession of the LEA.¶

The District Media Center will provide duplication services of various mediain VHS, DVD, and CD formats. This service will be for administrators, educators, and non professional in house trainers, as well as school groups and clubs. In the case of school groups and clubs, the school and its programs must be the beneficiary. The District media center will not provide duplication services for use in fundraising projects or activities. As technology advances, future provisions such as digital streaming will be considered. The purchase of additional, non-consortium audio/visual media materials will be considered upon recommendation. It must, however, be previewed, evaluated, and fit the core curriculum. All audio/visual media materials obtained through the consortium will be limited to the cost of replacement and are the responsibility of the school where the educator is employed. The District Media Center will maintain/house a permanent archive copy of all allowed consortium materials.¶

The following statements govern the use of the "District Media Production Center" by the School District employees:

3.21.21. Provided the duplication agreement is current, school principals and/or school media coordinators may authorize the duplication of UIMC or other materials for inclusion into their respective school media center. The cost of materials will be charged directly to any school account designated by the school. No purchase order is required.

3.21.32. The District Media Center houses a professional development library of various materials for educator checkout. These materials are the property of the Professional Development Department and can be checked out for 30 days. Replacement of lost or damaged items is the responsibility of the individual educator to whom the item is checked out. Items that become worn or damaged due to normal use are replaced at the option and expense of the Professional Development Department Development Department.

3.21.43. Projection lamps are available at The District Media Center that schools can order. Sales are on a cost only basis and can be charged to any school account.

3.24.14. A workroom containing items such as an internetas internet connected computer, die cuts, laminators, copy machine, and Poster Maker is located at the District Media Center. Paper and other various supplies are available for purchase or can be billed to individual school accounts. Educators can utilize this area during open hours to work on qualified projects. No purchase order is required.

3.21.65. Equipment for use in training and presentations is available for checkout from the District Media Center. Items included, but not limited to, are: audio tape players, CD players, and overheads. 3.21.76 As the need arises, special equipment such as digital cameras, GPS units, digitizing units, and tripods are purchased and made available for checkout at the District Media Center. Checkout times are flexible on these items.

3.3. School Media Centers Libraries

3.3.1. Washington County School District employees shall research and review all material before it is made available to students and disallow any material that is regarded as Harmful to Minors from placement in media center libraries.

3.3.2. Using available reviews, District employees shall select appropriate material as defined in the Standards for material selection.

3.3.3. Washington County School District employees shall not accept any contributions or donated material which does not meet the criteria as defined in the standards for material selection.

3.3.4. Media center library collections shall be updated regularly to meet curriculum standards, fulfill student and teacher demand. Material shall be weeded according to checkout frequency or known violation of the Standards for material selection.
